





MARKET ENVIRONMENT

- Trump's decisive victory in the US election is expected to provide him with significant leverage to advance his policy agenda.
- In November, the US stock market experienced robust gains, with major indices, including the Nasdaq, reaching new record highs.
- This impressive rally was largely attributed to Trump's victory, as investors anticipated potential benefits from his proposed tax cuts and deregulation policies.
- Conversely, stock markets in China, Europe, and Latin America experienced declines due to concerns over potential tariffs.
- The healthcare sector underperformed, driven by concerns following the nomination of Robert F. Kennedy, who has expressed skepticism about vaccines and aims to cap the prices of expensive drugs.
- Nvidia released its quarterly results in November. While investors were generally satisfied with the results, the company's outlook for the fourth quarter fell short of some analysts' expectations.

PERFORMANCE COMMENTARY

- Against this backdrop, the fund delivered a positive performance, slightly underperforming our reference indicator.
- We benefited from our high exposure to the technology sector, through Microsoft, Nvidia and Oracle.
- Our stock selection in the healthcare sector also paid off through Intuitive Surgical, Stryker and Veeva.
- Quality cyclical stocks performed well over the month, particularly in the consumer staples sector with Procter & Gamble and Colgate.
- Finally, our strategy suffered somewhat from our overexposure to the European markets, with consumer discretionary stocks Ferrari and Hermes.

OUTLOOK AND INVESTMENT STRATEGY

- Although some investors are anticipating a repeat of the 2016 scenario, we are taking a more cautious approach. We believe that much of the market's expectations have already been priced in (the outperformance of the Russell 2000 relative to the S&P 500 in 2016).
- In addition, the current environment differs significantly, particularly in terms of interest rate levels and budget deficits. The growth environment may not be as favourable as expected.
- Against this backdrop, and given the recent upturn in cyclical stocks, we continue to favour the most defensive companies in the technology and healthcare sectors. These companies offer high earnings visibility and are less exposed to economic uncertainties. They could benefit from a 'pro-business' environment, which would encourage innovation and the growth of our convictions.

GLOSSARY

Active Management: An investment management approach where a manager aims to beat the market through research, analysis and their own judgement.

Active share: Portfolio active share measures how different from the reference indicator the portfolio is. The closer the active share is to 100%, the less identical stocks a portfolio has compared to its reference indicator, thus the more active the portfolio manager is compared to the market.

Active Weight: Represents the absolute value of the difference between the weight of a holding in the manager's portfolio and the same holding in the benchmark index.

Alpha: Alpha measures the performance of a portfolio compared to its reference indicator. Negative alpha means the fund performed less well than its reference indicator (e.g. if the indicator increased by 10% in one year and the fund increased by only 6%, its alpha is -4). Positive alpha means the fund performed better than its reference indicator (e.g. if the indicator increased by 6% in one year and the fund increased by 10%, its alpha is 4).

Beta: Beta measures the relationship between the fluctuations of the net asset values of the fund and the fluctuations of the levels of its reference indicator. Beta of less than 1 indicates that the fund "cushions" the fluctuations of its index (beta = 0.6 means that the fund increases by 6% if the index increases by 10% and decreases by 6% if the index falls by 10%). Beta higher than 1 indicates that the fund "magnifies" the fluctuations of its reference indicator (beta = 1.4 means that the fund increases by 14% when the index increases by 10% but also decreases by 14% when the index decreases by 10%). Beta of less than 0 indicates that the fund reacts inversely to the fluctuations of its reference indicator (beta = -0.6 means that the fund falls by 6% when the index increases by 10% and vice versa).

Capitalisation: A company's stock market value at any given moment. It is obtained by multiplying the number of shares of a company by its stock exchange price.

Investment/net exposure rate: The investment rate constitutes the volume of assets invested expressed as a percentage of the portfolio. Adding the impact of the derivatives to this investment rate results in the net exposure rate, which corresponds to the real percentage of asset exposure to a certain risk. Derivatives can be used to increase the underlying asset's exposure (stimulation) or reduce it (hedging).

Net asset value: Price of all units (in an FCP) or shares (in a SICAV).

VaR: Value at Risk (VaR) represents an investor's maximum potential loss on the value of a financial asset portfolio, based on a holding period (20 days) and confidence interval (99%). This potential loss is expressed as a percentage of the portfolio's total assets. It is calculated on the basis of a sample of historical data (over a two-year period).

Volatility: Range of price variation of a security, fund, market or index, which enables the measurement of risk over a given period. It is determined using the standard deviation obtained by calculating the square root of the variance. The variance is obtained by calculating the average deviation from the mean, which is then squared. The greater the volatility, the greater the risk.

ESG: E for Environment, S for Social, G for Governance

ESG score Calculation: Only the Equity and Corporate Bond holdings of the fund considered. The model has three distinct modules, production model (used for power-generating utilities), company-specific intensity model (used for companies that have reported carbon emissions data in the past but not for all years), & industry segment-specific intensity model (used for companies that have not reported any carbon emissions data in the past). In the context of an individual fund or portfolio, alignment is defined as the portfolio-weight weighted average taxonomy alignment of included companies.
